- d. Squadron Reports: 1-3 minutes for Squadron Representatives to discuss ways their squadrons are preparing their cadets for encampment
 - i. C/Capt Peter said they are starting to use the Great Start program and are hosting an open house in June
 - ii. C/CMSgt Oplinger said they are teaching their cadets the necessary drill, what to expect, and what flies and what doesn't fly
 - iii. C/CMSgt Emaus said they have multiple cadets serving on staff. They are also giving them introductory training, ensuring they know how to pack, and ensuring they're prepared.
 - iv. C/SMSgt Fitzpatrick said they made an OI that's similar to the one at encampment
 - v. C/CMSgt Walker said they are expanding on drill and enforcing customs and courtesies
 - vi. C/CMSgt Radom said they are reinforcing drill and going back to the basics
 - vii. C/CMSgt Kenna said they are working on customs and courtesies and drill
 - viii. C/CMSgt Gragg said they are just working on customs and courtesies
 - ix. C/CMSgt Taylor said the cadets that have already been to encampment are talking to the cadets who are going this year
 - x. C/CMSgt Lane said they are making sure cadets are getting promoted for advanced flight, working on drill, and holding a Q&A about encampment

 - xii. C/CMSgt Bane said they are hosting packing classes and just giving advice to the cadets who are going this year

2. OLD BUSINESS

- a. Committee Reports: 1-3 minutes for Committee Chairs to describe any progress their committee has made since our last assembly
 - The ES Committee was supposed to meet with their stakeholders but their meeting fell through and are doing an overview of their proposal today.
 - ii. The Cadet IT committee said they are meeting with their new stakeholder and are editing their proposal
 - iii. The Cadet Training Committee said they had an idea for reading material for the "COVID Officer" but they changed their idea and finished their first draft of the outline of the event.
 - iv. The ES Patch Committee said they are looking at taking the old dog patch and putting it on the ABUs
 - v. The NCO Creed Committee is proposing this meeting
 - vi. The Recruiting and Retention Committee said they are working on their last edits of the proposal and should be ready to present next month

3. NEW BUSINESS

- a. NCO Creed Committee Proposal
 - i. This creed will give NCOs a sense of identity, build unity within the NCO ranks, and serve as a tool to guide their leadership development
 - ii. The creed is based on elements of the Army NCO creed and has many references to CAP documents
 - iii. The first paragraph has an opening sentence and states the core values which emphasizes their importance in all the NCO does
 - iv. The second paragraph lists the specific goals that all NCOs should have for how they conduct themselves and it elaborates on the standards that NCOs should hold for themselves
 - v. The third paragraph describes the NCOs' relations to the other members of CAP
 - vi. The fifth paragraph describes how by becoming an NCO you are voluntarily obligating yourself to take on the responsibility that comes with the rank
 - vii. The Cadet Oath and the NCO Creed have two different purposes; The NCO creed creates a sense of unity between NCOs and gives them a standard to live by while the Cadet Oath symbolizes how serious cadets are about coming leaders

 - The TLP is to create a short presentation on a specific's uniform's regulation and must integrate the concepts of self-discipline and attitude into it

 - a. Importance on ABUs in regs
 - b. Although ABUs aren't as classy as blues, they are still held to the same high standards as them
 - c. Wearing the uniform correctly upholds the cadet oath
 - d. It promotes that you need to uphold all the core values
 - 2. PT
- a. There isn't an official PT uniform regulation
 - i. The uniform depends on which squadron you're in
- b. "Informal" uniform
- c. It takes into account the core values
- 3. Blues
 - a. Only one way to wear the uniform, the right way
 - b. Representing something greater than yourself
 - c. It's the uniform with the most critique on the different parts
 - i. Ribbons, name tape, shoulder cord, shoes, etc
 - d. Respect for those who have fought and died
- f. Wing Commander Time
 - Colonel Angelovich said he was happy to see the CAC focusing on uniform wear
 - ii. He said they are seeing many issues with uniform wear especially with the cadets' hair and boots
 - iii. At the end of the day, appearance is one of the most important parts of CAP
 - iv. The uniforms that CAP wears represent the Air Force.
- g. The cadets then briefed Colonel Angelovich on their uniform presentations

- i. Colonel Angelovich then said that he is grateful CAC is doing this and hope that CAC can fix the uniforms he's seeing
